The "Roisterers" of old Wethersfield

Donald Lines Jacobus, in *Hale, House and Related Families*, mentions an amusing incident that took place at the house of Thomas Wickham, in December of 1679. Wickham's house was up at the north end of High Street, next to what is now the Cove:

John Hale (who was m. to Hannah Nott, daughter of old John Nott) was less prominent than his father or brother, and the reason may be found in a certain sophomoric trait in his character indicated in the following records. On 4 Dec 1679 "John Hale being complained of for abusive language & Notorious Ill carriage is by this Court committed to his Father Hale as his keeper till the Court in March next." The matter came up before then, at a special session held 22 Jan 1679/80. "Lnt Tho: Holister John Hale Wm Wickham for their vnseasonable meeting at Tho: Wickhams house Excessive drinking & playing at Cardes ... fined Thirty shillings a peice." It must have been a wild party, even for Puritan Connecticut. At the same court, a fine was assessed against "Lnt: Tho Holister for breach of the peace in smiteing downe John Curtice & Joseph Curtice." Nor did his victims escape, for Joseph Curtice was fined for playing cards and John Curtice for being drunk. "Mr John Hollister for his unseasonable keeping Company where such great disorders were," also sustained a fine, merely for countenancing such behavior by his presence, but his superior social position is conceded by the use of the term "Mr." even in this unsavory connection. He was, of course, brother of the doughty Lieutenant, who felled the two Curtises ... Thomas Wickham was also fined, for permitting his house to be used by the roisterers.

And that is where this matter ends, so far as our Curtises are concerned. As concerns John Hale, however, Jacobus continues:

But even worse was to come. "It being alledged by Thomas Wickham that John Hale upon Fryday last at night spake evill against our Lord the King sd Hale was committed to the Goale there to be kept in durance till Further order." Apparently he was kept in jail only over night, for the next day the Court sat again, to hear the heinous details and to render judgement. "Thomas Wickham personally appeared & produced Jonathan Strickland & Susanna Kircom who informed him that John Hale had sayd God Damne King Charles, The sayd persons being Examined both affirmed they heard him say: God bless King Charles, & in a fitt when he fell off his Chaire & foamed at his mouth & shakt every Joynt of him they thought he sd God damn King Charles but they durst not take oath of it he spake so lowe." This evidence was not strong enough for a conviction of lese majesty, and John Hale was released. If we may interpret the records, we take it that Hale at a drinking party was toasting the King, but fell off his chair and was so enraged that he turned to cursing the King. Those who were present, not wishing to get him into further trouble, developed a convenient uncertainty as to what they had actually heard him say. It may be supposed that he was badly frightened by this experience, and reformed his ways, for his escapades brighten the pages of the musty court records no more after this episode.

We would not want to leave this matter without mentioning that John Hale and Hannah (Nott) Hale were the grandparents of Nathan Hale, the Colonial Patriot (Codman, p. 5; also see Note 1).

There are two other items of record that bear on our Curtises in this context as well. Stiles notes the results of a midnight watermelon raid involving James² and Joseph² Curtis:

James and Joseph Curtis are prob. the parties, who in 16___, were (with Thomas Hurlburt, Jr., and Thomas Wickham) sentenced by the Gen. Ct. to imprisonment during the court's pleasure, for agreeing to rob Richard Smith's watermelon patch, and not only stealing five melons, but afterwards boasting of it. Finally there was the matter of the Dix girl. From the Hartford County Courthouse Records:

5 Sep 1702, Joseph Curtis (son of Joseph Curtis of Wethersfield, dec'd) accused by Margaret Dix of same town of being the father of her child.

Margaret Dix was the daughter of John² Dix; she would have been several years younger than Joseph³ Curtis, who would have been about 25-26 at the time. Joseph Curtis married in 1708 to Dorothy Edwards.

Notes:

For generations every school child in America knew about Nathan Hale, the young school master, who at the time of the Revolution became an ardent Patriot. Sent across the Sound on a mission to gather information about the British on Long Island, he was captured near Huntington, sent to New York, and hanged as a spy. His last words were reported to have been, "I only regret that I have but one life to give for my Country."

Richard:

I checked "The History of Ancient Wethersfield, Vol II", by Henry R. Stiles. He shows a Joseph 4 Curtis, born 1713, married 31 Oct 1732 Silence Williams; removed to Goshen, CT about 1740, in 1750 removed to Dutchess Co., NY; children Mary born 22 May 1733 and Honor baptised 5 Oct 1740. Joseph's ancestors were: Thomas I, 1598-1681 and Elizabeth

___; Joseph 2, 1644-1683, and Mercy ___; Joseph 3, 1675/6-1760 and Dorothy Edwards.

No mention is made of Joseph 4 having a son James; however, that does not prove that he did not have a son James. No other Joseph Curtis' are shown with a son James born in 1746 or any date near that.

This page contains all the information from the 1790 U. S. Census for this part of Schenectady County. The page numbers are those in the 200-300 range written in the upper right corner of the microfilmed page. Because the Schenectady County Public Library has microfilm for the later Heads of Families at the first census of the United States taken in the year 1790 rather than the original records, pages in that document are also included ("HOF").

Some of the original 1790 Schenectady census records suffered severe damage. (Central Library visitors may access our Ancestry subscription to see images of them.) The parts of the entries which could not be deciphered are marked with an asterisk.

A few corrections have been made for obvious misspellings, but otherwise the heads of families are listed as they were written.

In 1790, most of what eventually became the Town of Niskayuna was still part of what is now the Town of Watervliet in Albany County. Names for this area may be found at the Albany County NYGenWeb site. 1790 Duanesburg NY census shows Joseph and James Curtis:

Mr. ISAAC COE was born in Stratford, Conn., Nov. 22d, 1772, and married POLLY CURTIS, daughter of JOSEPH CURTIS, of Stratford, Conn. She was born March 29th, 1775, and married Sept. 5th, 1796. The fruits of this marriage were eight children, three sons and five daughters -- namely: MARIA, born in Conn., Sept. 15, 1797; ISAAC, born January 31, 1799; HULDAH, born Jan. 30, 1802, and died March 10, 1870. She was the wife of ASA HOLT. ELI, born July 23, 1805, and died June 24, 1829; MARY, born in Madison county, March 13, 1810, and died Jan. 14, 1862; JOHN B., born Jan. 5, 1813; ELIZA, born Dec. 19, 1814; ARIETTA, born Oct. 23, 1818. ISAAC COE was not as highly favored as many others with school privileges, but he was endowed with a quick and active mind, wise in his conclusions and able to give a reason for his views, which caused many to seek his advice and counsel. In early life he applied himself to farming, also engaging in the boot and shoe trade. In 1806 he sought a home in the west. Packing his goods, he, with his family, consisting of wife and four children, moved to what at that time was considered quite

a western section, Madison county. He was very active in the building up, and development of the county. He soon gathered around him a large circle of friends holding their good will and respect until his death, which occurred June 23d, 1841. His wife, POLLY COE, died Nov. 27th, 1858. Mr. COE, during the war of 1812, manifested his patriotism by engaging in it, showing himself a faithful soldier. He was a successful business man, leaving at his death a fine property. Three of his daughters occupy the old homestead and retain one hundred and sixty acres of fine farm land.

Notes for MARY ANN CURTIS:

Joseph Curtis came from Stratford, Conn., and settled on the north line of the town, on lot 4, and died July 15, 1840, aged 66, and Naomi, his wife, Oct. 9, 1846, aged 70. Robert, Samuel and Timothy Curtis came from the same place about the same time. Robert settled on land purchased of Nehemiah Thompson, on lot 17; and Samuel and Timothy, on Stratford street. Samuel died April 28, 1853, aged 85, and Lucinda, his wife, Aug. 30, 1855, aged 81.

ISAAC COE.

Mr. Isaac Coe was born in Stratford, Conn., Nov. 22d, 1772, and married Polly Curtis, daughter of Joseph Curtis, of Stratford, Conn. She was born March 29th, 1775, and married Sept. 5th, 1796. The fruits of this marriage were eight children--three sons and five daughters--namely: Maria, born in Conn., Sept. 15, 1797; Isaac, born January 31, 1799; Huldah, born Jan. 30, 1802, and died March 10, 1870. She was the wife of Asa Holt. Eli, born July 23, 1805, and died June 24, 1829; Mary, born in Madison county, March 13, 1810, and died Jan. 14, 1862; John B., born Jan. 5, 1813; Eliza, born Dec. 19, 1814; Arietta, born Oct. 23, 1818.

Isaac Coe was not as highly favored as many others with school privileges, but he was endowed with a quick and active mind, wise in his conclusions and able to give a reason for his views, which caused many to seek his advice and counsel. In early life he applied himself to farming, also engaging in the boot and shoe trade. In 1806 he sought a home in the west. Packing his goods, he, with his family consisting of wife and four children, moved to what at that time was considered quite a western section, Madison county. Here he purchased a large tract of land. He was very active in the building up, and development of the county. He soon gathered around him a large circle of friends holding their good will and respect until his death, which occurred June 23d, 1841. His wife, Polly Coe, died Nov. 27th, 1858. Mr. Coe, during the war of 1812, manifested his patriotism

by engaging in it, showing himself a faithful soldier. He was a successful business man, leaving at his death a fine property. Three of his daughters occupy the old homestead and retain one hundred and sixty acres of fine farm land.

The page numbers are those in the 200-300 range written in the upper right corner of the microfilmed page. Because the Schenectady County Public Library has microfilm for the later Heads of Families at the first census of the United States taken in the year 1790 rather than the original records, pages in that document are also included ("HOF").

Some of the original 1790 Schenectady census records suffered severe damage. (Central Library visitors may access our Ancestry subscription to see images of them.) The parts of the entries which could not be deciphered are marked with an asterisk.

A few corrections have been made for obvious misspellings, but otherwise the heads of families are listed as they were written.

In 1790, most of what eventually became the Town of Niskayuna was still part of what is now the Town of Watervliet in Albany County. Names for this area may be found at the Albany County NYGenWeb site.

Richard Curtis note:

Interesting that the 1800 census does not show James, so in that time frame evidently moved to McDonough NY where he is buried in 1818. The tombstone of James and his wife Jemima in Moore Cemetery shows that Jemima died in 1808 and buried in Moore Cemetery in East McDonough NY. So it seems reasonable to conclude that James migrated to East McDonough near Ludlow's Pond saw mill about 1799. Most of James children are also buried in Moore Cemetery in East McDonough NY. The only James Curtis appearing in web search of ancestry.com 1800 census in NY in 1800 is in Oneida county and Montgomery county. It could be that since per the History Of Chenango and Madison Counties New York book written by James H. Smith and published in 1880 by D. Mason & Co., Syracuse NY, that McDonough was utter wilderness in 1800, the earliest founder of the township of McDonough (Sylvanus Moore came in 1795 and the township created in 1816). It could be that in 1800 the East McDonough area was so remote that James was not found to interview for the 1800 Census. See <http://www.curtisit.com/curtis/> .html for history of McDonough from Mr. James Smiths' book. Note that Seth Curtis, son of James, farm was about 1/2 mile from Ludlow Pond. It may very well be that James and his teenage sons worked at the very first saw mill in the East McDonough area build by Mr. Ludlow in 1798 on creek feeding Ludlow Pond. Also note that per the before referenced book, Mr. Sylvanus Moore who emigrated to McDonough in 1795, married an Elizabeth Curtis, daughter of a Solomon Curtis in 1797. A History of Schenectady During the Revolution: Chapter XVI

The Mohawk Valley Laid Waste

[This information is taken from pp. 95-100 of A History of Schenectady During the Revolution by Willis T. Hanson, Jr. (1916). presented here since James Curtis likely fought with Col. Dubois in these battles and particularly the one at Ft. Kloch]

The enemy did not wait until spring to again commence their activities. In February, 1780, a small band effected some damage at German Flats, in March a settlement to the north of Palatine sustained a like invasion, and early in April came news of Brant's raid on Harpersfield.

Reports of minor raids, rumors of intended movements by the enemy on a large scale, actual suffering on the part

of the settlers for want of provisions, depreciation in Continental currency which had by now become practically worthless, and the difficulties of affording a semblance of protection by reinforcing the meager garrisons already posted, due to the impossibility of obtaining supplies for the militia, the only force available for this service, had by May brought about a most lamentable condition on the frontiers. As a result of this condition the more remote settlements were reported as daily breaking up and Colonel Van Schaick was led to express (1) the fear that unless some speedy and effectual measures were taken to inspire the despondent people with confidence, Schenectady would in all probability soon be the frontier to the westward.

At daybreak on the morning of May 22 the much feared attack of the enemy materialized, Sir John Johnson appearing on the Mohawk River at Tribes Hill with a strong force (2) of Indians and whites. From Tribes Hill the enemy proceeded westward "burning the Houses and Barns of the Inhabitants and putting to Death every Male capable of bearing arms." (3)

"Collo. Fisher (4) is mortally wounded," reported (5) Colonel John Harper from Johnstown on the same day, "and his two (6) Brothers killed, [and] old Mr. Douw Fonda (7) with seven others."

Of the Schenectady militia who had marched under Colonel Wemple "on the first alarm" some were almost immediately obliged to return for want of provisions (8) The remainder, however, hastened towards Johnstown and, joined by troops from Fort Hunter (9) under Colonel Harper (10) and others under Colonel Volkert Vedder, (11) swelling their force to about four hundred and fifty men, determined to engage the enemy should Sir John, who had rendezvoused there, show any disposition to fight. (12)

Sir John, although his force, swelled by the addition of many Tories who had hastened to join him, now outnumbered the American troops about two to one, did not offer an engagement, but almost immediately withdrew and, eluding the troops which Governor Clinton sent to intercept him, made his way safely back to Canada. (13)

The opportunity afforded by the dispirited condition of soldiers and settlers alike had early been seized upon by the British, who with no small success endeavored through their emissaries to stir up mutinies in the ranks of the main army or induce those holding Tory sentiments to take up arms in their behalf.

Many Tories had joined Sir John Johnson during his raid, and from time to time small bands from Albany and Tryon counties left to join the enemy. That a large party so inclined were assembled at Beaverdam was reported (14) to the Schenectady Committee on July 18. Colonel Vrooman (15) at Schoharie was at once apprised (16) of the fact that he might order out a detachment in an endeavor to intercept them, while in Schenectady a party was at once organized (17) for the same purpose. Although the Schenectady detachment after having marched all night arrived at the rendezvous at daybreak, they were successful in securing but three of the band who had secreted themselves in a barn, while the main body, having undoubtedly been alarmed, succeeded in making their escape. (18)

Late in July the enemy under Joseph Brant appeared in force before Fort Schuyler. This movement was probably a feint, for while the troops were hastening to the defense of the post, leaving the lower valley without adequate means of protection, Brant and his followers quietly withdrew and, advancing by way of the Unadilla and Susquehanna Rivers on August 2, fell upon Canajoharie.

The Albany and Schenectady militia, who had turned out with alacrity (19) under orders previously given, had just gone into camp at Caughnawaga (20) opposite Mr. Frey's at about eleven o'clock on the morning of the second, when they were alarmed by the heavy smoke "between John Abeails and Fort Plank about four miles distant." (21)

"Instantly I did order both Regiments to be formed," reported (22) Colonel Wemple in his dispatch to General Ten Broeck, "& proceed against the Enemy, who were at that time in their full Carear and tho our Numbers were not equal, yet I can assure you I should be void of Justice if I omitted mentioning their Prudence and cool behavior without Distinction to all Raneks. An Altho they had been in full march since early in the morning they came up with such Vigor that the Enemy on our approach gave way & tho in sight we had no opportunity to give them Battle they retired in the usual way."

"Such a Scean as we beheld since we left the River," reads another section of the report, "passing dead Bodies of Men & Children most cruelly murdered, is not possible to be described. I cannot ascertain at present the Number of poor Inhabitants killed and missing but believe the Loss considerable as the People were all at work in the Fields... Some Persons pretend to say not less than one hundred dwelling House are burnt."

On August 21 Colonel Goose Van Schaick, writing (23) to General Washington from Albany, confirmed the details of the withdrawal of Brant from Fort Schuyler and of the attack on Canajoharie. "From thence," continued the letter, "they returned towards the susquahanna, & in a few days after made a Descent on Schohary; here they burnt twelve Houses, & have by information taken and killed a larger number of the Inhabitants than at the former place, & it is expected the remainder of Schohary will share the same fate. The Indians are seen daily in small parties, & take prisoners & Scalps, Schenectady is threatened & the Inhabitants are moving their effects to Albany with all dispatch seeing no appearance of support, & numbers going off to the enemy daily."

In England Riverton's Royal Gazette told of the successful progress of the expedition. "The Indians have laid waste the whole country," reads its issue (24) of September 23, "the Tory houses excepted, down to Schenectady, where some rebels are at work throwing up works to oppose the progress of the British troops and our Indian allies. The rebel women and children have retired to Albany."

With the aid of a negro slave belonging to one of the neighbors Colonel Visscher managed to reach friends, who at once sent him to Schenectady by canoe. Here he received medical attention and subsequently recovered from his wounds.

"VILLAGE OF ILION.

There was nothing meriting the name of a village on the site of Ilion until after the completion of the Erie Canal, yet there was a store there as early as 1816, and perhaps earlier, a fact which is attested by shiplasters of Thomas Gillespie & Son of that date. In early years the western part of the present corporation was called "London." After the construction of the canal the locality was known as Morgan's Landing, while on the canal list it was called Steele's Creek."

"The following interesting and comprehensive account of the place was written by William Hibbard "

. Still farther west and near the creek, was the residence of Adam Steele. The school-house was located on the site of Long's barn, near the old feeder, but was afterward moved to about half way between Dennis Dygert's storehouse and the bridge first mentioned. Opposite this bridge, and close to the towpath, was the "Seth Curtis House," occupied by Mr. Lawrence Helmer, which is still standing, and is distinguished as the old brown tenement, third building east of the Agricultural Works; farther to the east was the residence of Esquire Helmer. This property was afterwards bought of Mr. Harter by William Jinks, inventor of the Jinks carbine, who erected a new dwelling in the place of the old one; and later it passed into the hands of Esquire Rasbach, by whose family it is now occupied. Such was Ilion in 1831"

"The Baptist Church of Guilford was organized as the Baptist Church of Fayette, June 3, 1843, as a branch of the church in Oxford, and was composed originally of Russell Dibble, Salina Dibble, Susannah Smith, Susan Merchant, Abigail Laraway, Loritta Cable, Eliza Saunders, Anthony Williams, Polly Williams, John Edson Dibble,

Elizabeth Guy and Hammon Guy, who were then residing in Fayette and vicinity and were members of the church in Oxford. Six others had joined during the year four by letter and two by baptism, viz. Alonzo Hendrick, Clarinda Hendrick, Frances H. Morgan, Mary L. Smith, by letter, and Daniel Dibble and Henry Van Cott, by baptism. "

"Rev. E. G. Perry was the first pastor. He closed his labors April 27, 1844. The latter date they resolved to form a Sabbath school, and a Mr. Gorham, from Madison University, was to visit them for that purpose and to preach for a few weeks. "

"June 8, 1844, they resolved to organize as a separate church, and Russell Dibble, John Hull, Jr., Alonzo Hendrick and John M. Wilcox were appointed a committee to draft articles therefor. June 30, 1844, articles reported by the committee were adopted. July 21, 1844, the Church of Oxford was petitioned for permission to withdraw for that purpose. The names affixed to that petition, in addition to those already given, are: Gardner Wade, Harrison H. Van Cott, George Knapp, Roxana Brant, Elizabeth Hull, Salome Wade, Esther Hendrick and John Hull, Jr. Aug. 27, 1844, the covenant of the Oxford church was adopted, and they were recognized by a council which convened at the house of R. Dibble, and was composed of the following delegates: Elder O. Bennett, Sylvanus Moore, Benjamin Randall, Seth Curtis and William Willcox, from the church in McDonough; Deacon S. Yale, Uriah Yale, Elam Yale and Mark Yale, from the Second Guilford church; David P. Willoughby and Leontes Hendrick, from the church in Coventry; Lyman Root, Samuel Root, John Perry, David Hayes, John Gray and Randall Maine, from the church in Oxford. "MCDONOUGH VILLAGE.

McDonough is situated in the west part of the town on Genegantslet Creek, from which it extends nearly a mile west, and is distant about 9 1/2 miles from Oxford. It contains two churches, (Baptist and Methodist Episcopal,) a district school, one hotel, which was built about 1844, by John F. Hill, has since received several additions, and is now kept by William L. Brown, five stores, two tanneries, two saw-mills, one grist-mill, a woolen-mill, four blacksmith shops, (kept by William R. Runyan, William Arnold, Levi Sanford and Bruce Sanford,) two wagon shops, (kept by Henry M. Lamb and Milton A. Pike,) two cooper shops, (kept by Thomas Dunning and Nathaniel Thornton,) a harness shop kept by Lafayette Bennett, (this business was carried on by William Smith from about 1840 till his death, March 14, 1878. He was succeeded by his son Charles E., who continued it one year. Bennett came in 1878,) and a population of about 300. "

Richard Curtis note: re: proof that Seth Curtis of Chenango County was the Seth Curtis father of John Thurston Curtis: 05/18/02: The original genology research done by Charlie Curtis while living in New York city is on old carbon paper and was handed down to Earl and Mary Wells Curtis and then to Jack V. Curtis my father. Inspecting those pages in Richard Curtis possession shows handwriting notes I recognize as those of Mary Wells Curtis. She had hand written on these carbon papers compiled in November 1966 saying that John T. Curtis was John "Thurston" Curtis and that this was "PaPa Curtis mother and father". Further in handwritten notes on carbon pages she has written beside Seth Curtis and wife Anna Fitts that these were "PaPa C grandparents". On these pages below Seth are listed children James Harvey Curtis, Palmyra Curtis, Sallie Curtis, John T. Curtis, Edmund B. Curtis, Adelaide E. Curtis, Charles Edgar Curtis (starved to death in Salisbury S.C. while a prisoner of war), Lovisa E. Curtis, Lowrane A. Curtis, William Henry Curtis, and Harriet A. Curtis. Further my review of the U.S. census of 1840 shows 4 boys whose ages in these records all match the ages of males catagorized on the 1840 census...the girls ages on our records also match the 1840 census of Seth Curtis of Chenango County NY.

Seth appears to have been a teenager , when his father James, about 57 at the time, moved the family south from Duanesburg, to McDonough NY in about 1800.

Per Tuttle paper in Norwich NY library presented to DAR 1941, Seth lived on the home farm where his children

were born and in later years removed to the village of McDonough to the Samuel Smith house north of the Tucker home (gone in 1941). Seth was married to Anna by the Rev. WHITE STORE.

White Store is situated on the Unadilla, in the east part of the town, and is a station on the New Berlin Branch of the Midland Railroad, with a population of sixty-three. It contains a Union Church, built in 1820, by members of the Baptist, Methodist and Universalist denominations, a district school, a grist-mill, two groceries, kept by J. T. Curtis and Caleb Barr, the latter of whom is the postmaster, having been appointed to the office April 19, 1874. Mr. Barr was preceded in the office by William T. Morse, who held it about two years. David Shippey previously held it a great many years. The postoffice at this place was established at an early day.

Richard Curtis note: I find it interesting that John Thurston Curtis, whose father and grandfather spend many years living in Duaneburg NY, when John Thurston gets off train from migration NY to KY, settles at Waynesburg, KY. Names of towns sound very much alike.

Per Jack Curtis, writer's father, John C. Curtis fell from apple tree as young boy and broke his ankle. They couldn't get it set properly and so it never healed properly, resulting in as a mature man, one leg being shorter than the other by about one inch. He had to wear built up shoes on one foot to compensate for this. Pictures on this site show this.

Jack Curtis also said that John C. Curtis was the main person behind getting into the flour mill business in Somerset KY and was the President of the Flour/mill company. Jack said he thought it was probably because he had put the most money into it. It was John C. Curtis's guaranteeing a nephew's bank loan to purchase the first Chevrolet dealership in Somerset that in the depression caused the bank to call guarantee of John C. Curtis and eventually started the downward spiral resulting in the loss of the Mill by foreclosure as well as the family home in Somerset.

As told by Jack Curtis to son Richard 11/18/2000 over dinner at Mrs. Winners chicken:

Started out talking about going to Somerset and took some pictures of old acquaintances he looked up. Said the last time they went down to Somerset saw an old friend Ed Tucker. Said Ed was a football player and he had several brothers that were big football players at Somerset high school. He said he didn't know why Ed had taken to him, but for some reason he had. Ed was originally in his high school class, but he may have flunked a grade and got behind. Ed had gotten to go to college at Bowling Green and had obtained a teaching certificate that enabled him to teach school. In the summers, since teachers only worked 9 months a year, he had to get any work he could in the summer and had driven a delivery truck of some sort. Several years ago at a high school reunion, he had shown up and every knew him, even though he really did not graduate with Dad's class since had fallen

behind a year. Dad said gratefully that Ed said that he had just come by to see Jack Curtis. Dad seemed very pleased and honored, but did not know why Ed had taken to him. He said that when he would go to Somerset to visit "Dad and Mother" Ed would drop by the house and visit with them.

Dad told of a time when he was delivering papers, he had Dot with him for some reason and was coming down the hill home, with his paper bags over his shoulder with Dot with him. That a tall skinny boy a year or so older, know to pick on kids younger than he, named Rat Hargis came out and stopped Dad trying to pick on him and would not let him pass. Dad said "...I became more concerned because Dot was only about five years old at the time and she was walking on ahead and would have to cross the busy street down below to get home." He was saying to Rat "...come on let me go, I have to go. About that time Ed Tucker who lived within the block came by and said to Rat "...let him go, leave him alone. Ed was a big football player type and so could take up for Dad and Rat would back down from him. Rat told Ed that Dad had done something or said something to irritate him, but Ed told Rat to leave him alone. Dad said that since he had Ed there taking up for him, who was bigger than either of them, and he knew Rat would not do anything with Ed there, he jumped up and socked Rat. (making a face of tight lips and motioning of punching). He laughed.

He said some days later, he was on his way home on his bicycle after delivering papers with one paper bag over his shoulder and the other in the Bike front basket. He came around the corner to go down the street (South Central) at the Methodist Church and there was Rat. He said he tried to ride to the other side to avoid him, but Rat ran up and grabbed his paper bag and pulled him off his bicycle. They started fighting, just going at it. Dad said they were kind of out in the street fighting and traffic was stopping and people watching. He said Rat was so much taller that Dad had to jump up and punch to try to punch Rat in the face. He laughed saying it must of looked quite funny him jumping up fighting like a bainty rooster.

Dad said they fought on like this until a black gentleman who worked the the only men's clothing dept store stopped. He saw that dad and Rat were tired of fighting and worn out, so he separated them, and said they needed a break. So he separated them and said "you have a three minute rest between rounds." After a few minutes, it sent them back to fighting.....He said this went on for about three rounds until both were so tired, they finally quit. Dad said after that, though, Rat never picked on him again.

As told to Richard Curtis by father Jack Curtis 12/9/2000:

When Jack was a boy his parents lived on a 4 acre place outside town near Pisgah community. Described a near the side of town where the Mill was. Said they had a few pigs, chickens, and milk cow. Said that during the depression, they bought groceries from the Sam Colyer Grocery store near the Mill. They could not afford to pay for the groceries all the time so Mr. Colyer was real good about letting them go on account. The bill had gotten up pretty high, so Earl Curtis went down and worked out a deal with Mr. Sam Colyer to trade the old milk cow toward their grocery bill. The milk cow had gotten old and they said it wasn't giving good milk anymore. So Earl gave Jack Curtis the job of leading the old milk cow to the slaughter house and sell it to slaughter so the money could go toward the grocery bill. Jack said that he had to have some help to lead the cow over to the slaughter house as it was accross town and the cow would get jittery going through town. But they got it over there and accomplished their chore and paid down on the grocery bill.

Jack Curtis said he had kind of met my mother and would go see her at my Aunt Ruby's grocery store after delivering papers on his paper route during the depression. Ruby Colyer's store was down in a bottom that was accross the street from the stockyards in Somerset. Jack's paper route included the street that led down into the bottom and goes by the Somerset cemetary.
